ELIGIBILITY

1. Nominees must be employed by a company that is a member of KMCA.
2. Nominees must be responsible for supervising truck safety activities for the previous 12-month period for said employer.
3. Previous KMCA Safety Professional of the Year winners are ineligible for five years from the date of their award.
4. Judging will be based on professional achievements, success in advancing highway and industrial safety in the fleet, relationship and cooperation with government officials, and methods of meeting and solving safety problems facing the nominee's fleet. Work and leadership in the safety activities of state trucking associations, the American Trucking Associations, Inc. and other organizations of safety professionals are of high importance.
5. The individual selected as the 2023 KMCA Safety Professional of the Year will receive a plaque provided by the Kansas Safety Management Council and be recognized in KMCA Publications.
